## THE SCOTTISH CIVIL JUSTICE COUNCIL AND ITS COMMITTEES

## Purpose

1. To provide an overview of the structure and remit of the Scottish Civil Justice Council (SCJC) and its committees, highlighting what rules each committee will be preparing under the rules rewrite project.

## **Background**

2. There are a number of committees involved in the preparation of rules under the rules rewrite project and the attached diagram provides a one-page summary that aims to clarify how each committee links into the rules rewrite project.

3. The role of SCJC is to prepare draft rules of procedure for the Court of Session and for civil proceedings in the sheriff court. Its remit also includes providing advice and making recommendations to the Lord President on the development of the civil justice system in Scotland.

- 4. In its first year of operation, the SCJC has focussed on preparing for implementation of civil courts reform and has established five committees and a working group to progress this work:
  - The Family Law Committee
  - The Access to Justice Committee
  - The Personal Injury Committee
  - The Costs and Funding Committee
  - The Information and Communications Technology Committee
  - The Rules Rewrite Working Group (to become the Rules Rewrite Committee)

#### Recommendation

5. That members note the structure of the Council and its committees and their responsibilities within the rules rewrite project.

## THE SCOTTISH CIVIL JUSTICE COUNCIL (SCJC) Chair – The Lord President, Lord Gill

The role of the SCJC is to keep the civil justice system under review; review practice and procedure followed in the Court of Session and in civil proceedings in the sheriff court; prepare draft rules of procedure for these courts; and provide advice and make recommendations on the developments of and changes to the civil justice system. The SCJC has broad powers to help it carry out its functions, including the ability to make recommendations to the Scottish Ministers, carry out consultations and commission research. It may set up committees and ad hoc working groups to assist in carrying out its functions.
