## Item 1: Introduction, welcome, apologies and private papers

- The Chair welcomed Ian Dickson, Scottish Legal Aid Board, who was attending
  for Colin Lancaster, and all those present to the meeting. The Chair noted that
  the meeting would be focusing, once again, on the Simple Procedure rules.
- 2. The Chair thanked Judge d'Inverno for his excellent presentation at the SCJC Information Event in Parliament House on 2<sup>nd</sup> July. Members noted that they found the event informative and useful.
- 3. Apologies were noted.
- 4. Members agreed not to publish Papers 2.2, 5.1, 5.1A-C and 7.1.

### **Item 2: Previous Meeting**

Item 2.1: Minutes of previous meeting [Paper 2.1]

- 5. Members agreed the minutes from the previous meeting.
- 6. The Chair advised the Committee that Judge d'Inverno's papers on reconsideration of judgments, case management and judicial mediation in the Employment Tribunal were considered by the Council at its meeting on 06 July 2015. The Council submitted the papers on case management and judicial mediation to the Family Law Committee for further consideration. The paper on reconsideration of judgments will be reconsidered by the Council in 12 to 18 months' time in view of the timed deadlines to which the Rules Rewrite Team is working over the next year.

8. Bridget Lee provided an update on the activities of the SCJC and its Committees.

### Item 4: Forward Work Planner

Item 4.1: Update from the Scottish Government on legislative developments [ORAL]

- 9. Denise Swanson was unable to attend and had provided a brief update, that the Programme for Government does not include a legislative slot for the Taylor Bill, which was delivered by the Chair.
- 10. Item 4.2: Update from the Scottish Legal Aid Board on Making Justice Work Project 3: Enabling Access to Justice [ORAL]
- 11. Ian Dickson provided an oral update from the Scottish Legal Aid Board on *Making Justice Work* Project 3: Enabling Access to Justice. While this project has come to a close, various strands are continuing, and planning and coordination is on going. The funders' framework will be discussed at a meeting in October. The grant funding work is attracting attention and an announcement will be made later this year about extending funding. An independent researcher has been appointed for the ADR project and work on this is underway.

## Item 4.3: Rules Rewrite: Update [ORAL]

12. Luke McBratney provided an update on the work of the Rules Rewrite team since the last meeting. The first big wave of Courts Reform changes will come into force on 22<sup>nd</sup> September and they are: judicial review, all-Scotland personal injury court, exclusive competence and Sheriff Appeal Court (Criminal). The rules were made in June and the RRDT have been working to increase awareness of the changes. The new simple procedure rules and Sheriff Appeal Court (Civil) rules are currently being worked on.

# Item 4.4: Lay representation: update from CAS on the discussion event and final report on Lay Representation in Scotland's Civil Courts [Paper 4.4] [ORAL]

- 13. Lauren Bruce provided an oral update. The Committee had previously seen the CAS/Shelter report *Lay Representation in Scotland's Civil Courts* in draft. The final report provided a baseline to move forward from. The discussion event on 2<sup>nd</sup> July was attended by some 30 lay representatives from all over Scotland and for many it was the first time they had met others carrying out the same role.
- 14. It was noted that the model for lay representation is different in England and Wales where lay representatives can be paid for their services by those they are representing whereas in Scotland they cannot, although many lay representatives are salaried employees of local authorities and advice bodies.

15. Ian Maxwell had tabled a discussion paper about lay representation under AOCB

[Paper 7.1]. However, as he was not able to attend the meeting, consideration of

this paper was postponed to the next meeting in order that Mr Maxwell could

speak to his paper.

Item 5.1: Rules for a Simple Procedure [Papers 5.1 and 5.1A-D]

16. The Committee considered Paper 5.1, an overview of the current position on the

draft simple procedure rules, Paper 5.1A, the revised draft of the simple procedure

rules including forms and orders and Paper 5.1B which set out the main changes

that had been made to the draft rules since the last meeting.

17. The Committee discussed various amendments to the draft provisions and

approaches that could be taken to those areas yet to be drafted. It was noted

that a further draft will be available for the next meeting in November.
